## "GIVING TUESDAY" - NOVEMBER 27, 2018 A DAY TO REMEMBER MATER DEI CATHOLIC HIGH SCHOOL

Celebrated on the Tuesday following Thanksgiving (in the U.S.) and the widely recognized shopping events of Black Friday and Cyber Monday, "Giving Tuesday" kicks off the charitable season, when many focus on their holiday and end-of-year giving. Since its beginning in 2012, "Giving Tuesday" has become a movement that celebrates and supports giving and philanthropy, a day dedicated to service and giving back. The day is meant to harness the potential of social media and enlist the generosity of individuals who wish to make a financial contribution to a charity that they hold close to their hearts.

Last year Mater Dei Catholic High School participated for the second time through its on-line giving portal. In our second attempt we raised \$2,396.00 from 23 donors. Our efforts this year will be to get the word out sooner and wider. You will also have the opportunity to choose which of the four funds (or combination of them) to which you desire to contribute.

Remember, your contribution to Mater Dei Catholic High School goes a long way to help in our mission to provide an excellent Catholic secondary education that is affordable, available, and accessible to every student who desires to attend Mater Dei. The cost to educate a student at Mater Dei this year is \$8,730.00, of which the tuition covers only \$5,536.00. Our fund-raising efforts per student are \$1,778.00. We rely upon the generous support and contributions from individuals like you who recognize the priceless treasure Mater Dei has become.

As we look forward to November 27, keep in mind the beautiful motto: "A generous person is enriched through the act of giving."

# THE POWER OF POSITIVITY



Recognizing the need for organizational goals, the group adopted the following:


- ❖ To help make Mater Dei Catholic High School a happy, safe, and positive place to work, learn, and grow.

# THE MATER DEI FOUNDATION

The Mater Dei Foundation was organized to promote Catholic education at Mater Dei through financial support. Contributions to the Foundation are invested and earnings on investments are distributed annually to Mater Dei Catholic High School. The Foundation is a Corporation organized within the meaning of Section 501 (c) (3) of the Internal Revenue Code. The Corporation is managed by a ten-member Board of Directors which meets quarterly. Each member serves a six-year term. The Board attempts to maintain geographical representation. Members of the Foundation are all persons who have contributed to the Foundation through the Mater Dei annual fund drive during the previous year. An annual meeting is held in August for those members.

The Foundation's assets and the day-to-day administrative issues associated with those assets are managed by an investment committee consisting of at least two directors. The committee follows guidelines set forth in the Mater Dei Foundation investment policy.

A gift to the Mater Dei Foundation is an investment in the future. It is truly a "gift that keeps giving." Your contribution is invested. Only earnings on the investments are distributed to Mater Dei Catholic High School, preserving the contribution is invested.

Contributions to the Mater Dei Foundation can be made in several ways:

- \* Through the Mater Dei annual fund drive by marking the appropriate box on the fund drive remittance envelope
- \* Through memorials, as requested by families upon the death of a loved one
- Through estate planning: wills, bequests, gift annuities, life insurance, charitable trusts
- Through an outright contribution anytime
- Through gifts of stock which are sold and the proceeds invested

# MAKING A PLANNED GIFT TO MATER DEI SHARING IN THE MISSION: TODAY AND INTO TOMORROW

#### What are Planned Gifts?

The techniques of charitable gift planning include both revocable and irrevocable arrangements, gifts available for use at the time they are given and gifts that may not be available until a future date, and split-interest gifts intended to balance financial, personal, and charitable objectives. These techniques are called "planned gifts."

Planned gift, deferred gift, estate gift are different names for a way to manage your affairs, plan for the future, and make a gift to Mater Dei Catholic High School, Breese, Illinois. Planned gifts are a variety of charitable giving methods that allow you to express your personal values by integrating your charitable, family, and financial goals. Making a planned charitable gift usually requires the assistance of a knowledgeable advisor such as an attorney, financial planner, or CPA to help structure the gift. Donors should seek charitable gift planning advice from professionals with integrity, expertise, and experience in law, investments, property, tax, and charitable transfers in order to assure both the technical merits of the transfer and the philanthropic quality of the gift.

Planned gifts can be made with cash, but many planned gifts are made by donating assets such as stocks, real estate, art pieces, or business interests – the possibilities are endless, considering all types of real and personal property and tangible and intangible assets. Planned gifts can provide valuable tax benefits and/or lifetime income for you and your spouse or other loved one. The most frequently made planned gifts are bequests to charities, made through your Will. Other popular planned gifts include charitable trusts and charitable gift annuities.

#### Why should I make a "Planned Gift"?

Many people want to make charitable gifts but need to do so in a way that helps meet their other personal, family, or financial needs. Planned gifts give you options for making your charitable gifts in ways that may allow you to:

- ❖ Make a larger charitable gift than you thought possible
- Increase your current income
- Plan for the financial needs of a spouse or loved one
- Provide inheritances for your heirs at a reduced tax cost
- Reduce your income tax and/or avoid capital gains tax
- Diversify your investment portfolio
- \* Receive income from your personal residence or farm
- Plan for the transfer of your business
- Leave a charitable legacy for future generations

The planned gift component of the Mater Dei Advancement Office is under the direct supervision of the Mater Dei Foundation Board. Advising the board will be a committee which is made up of members of the Foundation board, friends of Mater Dei, and a member of the administration of Mater Dei Catholic High School. The purpose of the committee will be to identify and cultivate prospective benefactors of Mater Dei. Each member will be responsible for personal contacts with those individuals or families that the committee has identified as possible benefactors of Mater Dei.

The committee will organize and sponsor community service workshops, which will consist of seminars on Wills and Probate, and Trust and Estate Tax information. It is the intent of the committee to provide an attorney for any legal information that will be requested. The committee will also provide handouts and written documentation of the proper procedures of planned gift giving.

## HOMECOMING THROUGH THE YEARS

In the first years of Mater Dei, because there was no football program, the Queen was crowned during basketball season, and was dubbed the Basketball Queen. The Unit I (Breese) and Unit II (Carlyle) sites each crowned a queen.



In the early years, Queens did not have to be seniors, as evidenced in the first school year, 1954-1955, when the student body voted a junior and a sophomore as Co-Queens.



Kings were not yet crowned but the Queen had an escort, as did the Ladies on her Court. "Lady Edra of the House of Voss escorted by Sir Howard of the House of Kapp." -1961 yearbook



In the early to mid-1960's, the bonfire was a prelude to the dance that launched another basketball season. -1964 yearbook




In the 1967-1968 school year, with the advent of the Mater Dei football program, MD began crowning a Football Homecoming Queen. This also was the first year that the Mater Dei Homecoming Parade began its long running tradition.

Throughout the decades of the 1970's, 1980's, and 1990's, Homecoming became a weeklong celebration that included the parade and class float competition, Mass, costume day, class-color t-shirts, the coronation, bonfire, class games (tug-of-war, foot races, balloon toss, etc.), the football game, and the dance, which closed out Homecoming Week.


